VOTING INSTRUCTIONS

- 1. Ballots are provided for **primary members** only. Joint owners may not vote.
- 2. To vote, you must be 16 years or older by the end of 2024 and have been a member of Education First Credit Union on January 1, 2025.
- 3. You may vote for 2 candidates or less. However, voting for more than 2 will invalidate the ballot. **Vote for not more than 2 candidates.**
- 4. Your **signature** and your **account number** are required to validate the ballot.
- 5. To mail: fold and tape (no postage required). **Do not staple.** DO NOT ENCLOSE ANY OTHER CREDIT UNION BUSINESS WITH THE BALLOT.
- 6. Official Ballots must be mailed directly to the address on the reverse of the ballot and received by February 28, 2025, to be considered a valid ballot. Ballots will be accepted at Credit Union offices. Ballots will not be accepted in night depositories.
- 7. Election results will be announced at the Annual Meeting on Tuesday, March 25, 2025, at Education First Credit Union / 510 E. Mound St., Cols., OH 43215 at 5:45 pm. SEE PROFILES OF CANDIDATES ON REVERSE SIDE.
